# "Release Version of FMA™" Ontology License

#### Introduction

The FMA<sup>™</sup> (also known as Digital Anatomist-Foundational Model of Anatomy) is a reference ontology for the domain of anatomy and is an active, curated ontology. It is an ongoing project under the supervision of Jose Mejino MD, the primary curator of the FMA<sup>™</sup>. The FMA<sup>™</sup> was created and developed by Professor Cornelius Rosse MD DSc., Jose Mejino MD., Augusto V. Agoncillo MD., and Richard F. Martin Ph.D., in the course of research conducted at the University of Washington ("UW"). FMA<sup>™</sup> development is supported by the research contributions of members of the Structural Informatics Group from the Department of Biological Structure, in the UW School of Medicine. The FMA<sup>™</sup> was supported in part by federal funding from: National Library of Medicine (NLM) Contract 97-081/VMS, RO1 LM06822, RO1 LM006316 and Defense Advance Research Project Agency (DARPA) Contract W81XWH-04-2-0012.

UW is making the "Release Version of the FMA™" available consistent with NIH's Research Tool Guidelines and other U.S. federal grants for which the FMA™ has been provided as a reference ontology.

The FMA<sup>™</sup> Research Project website is the sole source of the "Release Version of the FMA" and is current as of the date it is downloaded from the FMA<sup>™</sup> website. There is no charge for users to download the Release Version of the FMA<sup>™</sup> at: <a href="http://fma.biostr.washington.edu/download">http://fma.biostr.washington.edu/download</a>

The Release Version of the FMA<sup>™</sup> is appropriate for all research and development activities. The "Release Version of the FMA<sup>™</sup>" Ontology is a snapshot of the FMA<sup>™</sup> and it is current as of the date it is downloaded from the FMA<sup>™</sup> web site.

FMA<sup>TM</sup> Master Ontology is a curated database and it is under constant revision. The FMA<sup>TM</sup> Research Project does not make the FMA<sup>TM</sup> Master Ontology available for distribution because the Master Version of the FMA<sup>TM</sup> includes work-in-progress, project documents and contributions which are under consideration and have not yet been accepted by the FMA<sup>TM</sup> Research Project.

This License permits access to the Release Version of the FMA<sup>™</sup> and makes it possible for Licensees to use the Release Version of the FMA<sup>™</sup> for research, educational and commercial activities.

Potential users of the FMA<sup>™</sup> shall agree to the FMA<sup>™</sup> License Agreement prior to downloading the Release Version of the FMA<sup>™</sup> from UW.

### TERMS AND CONDITIONS FOR USE, REPRODUCTION, AND DISTRIBUTION

#### 1. Definitions

"Assignee" shall mean any person or entity that assumes full obligations, rights, and responsibilities of this agreement. This includes any sub-license agreements.

"Contribution" shall mean any work of authorship that is related to the FMA™ (including the original version of the Work and any modifications, deletions or additions to that Work) that is intentionally submitted to the FMA™ Research Project accompanied by a completed Contribution Agreement for inclusion in the FMA™ Master Ontology or the Work by the copyright owner or by an individual or Legal Entity authorized to submit on behalf of the copyright owner. For the purposes of this definition, "submitted" means any form of electronic, verbal, or written communication sent to the Licensor or its representatives, including but not limited to communication on electronic mailing lists, and issue tracking systems that are managed by, or on behalf of, the Licensor for the purpose of discussing and improving the Work, but excluding communication that is conspicuously marked or otherwise designated in writing by the copyright owner as "Not a Contribution."

"Contribution Agreement" shall mean the agreement to the terms and conditions for submitting a Contribution to the FMA™ Research Project as identified in Appendix B.

"Contributor" shall mean any individual or Legal Entity on behalf of whom a Contribution has been received by UW and subsequently incorporated within the Work.

"File Format Conversions" shall mean format conversions as identified in Appendix A. The FMA™ is File Format independent and File Format Conversions are not considered original works of authorship.

"FMA™" shall mean all of the research output including the "FMA™ Master Ontology," the "Release Version of the FMA™, and associated documentation and materials as developed and curated by the FMA™ Research Project.

"FMA™" Master Ontology" shall mean the controlled master of the FMA™ which is under development by the FMA™ Research project and is distinct from the Release Version of the FMA™. The master copy is not available for distribution under any circumstance and therefore is not covered by the license.

FMA<sup>™</sup> Research Project" shall mean individuals modifying the FMA<sup>™</sup> under the direction of Jose Mejino MD., the primary curator of the FMA<sup>™</sup>.

"Legal Entity" shall mean the union of the acting entity and all other entities that control, are controlled by, or are under common control with that entity. For the purposes of this

definition, "control" means (i) the power, direct or indirect, to cause the direction or management of such entity, whether by contract or otherwise, or (ii) ownership of fifty percent (50%) or more of the outstanding shares, or (iii) beneficial ownership of such entity.

"License" shall mean the terms and conditions for use, reproduction, and distribution as defined by Sections 1 through 11 of this agreement.

"Licensee" shall mean an individual or Legal Entity exercising permissions granted by this License.

"Licensor" shall mean the copyright owner or entity authorized by the copyright owner that is granting the License.

"Modifications" shall mean any work that is based on (or derived from) the Work and for which the editorial revisions, annotations, elaborations, or other Modifications represent, as a whole, an original work of authorship. For the purpose of this License, File Format Conversions and/or adding or deleting a single anatomical concept from the FMA™, are not a considered an original work of authorship. Modifications shall not include works that remain separable from, or merely link to the interfaces of the Work and Modifications thereof.

"Ontology" shall mean a formal and explicit specification of objects, their properties and relationships in a specified area of reality into a specialized schema that supports the organization of data in databases.

"Release File Format" shall mean the file format for the Release Version of the FMA™ as identified in Appendix A.

"Release Version of the FMA™" shall mean the released version of the FMA™ as identified in Appendix A and as made available to the Licensee under this License and shall be the preferred form for creating and distributing Modifications.

"UW" shall mean the University of Washington, an institution of higher education having its administrative offices in Seattle, Washington, through its office UW TechTransfer Digital Ventures 4311 11th Avenue NE, Suite 500, Seattle, WA 98105-4608.

"Work" shall mean the Release Version of the FMA™, and any work of authorship related to the FMA™ and made available under the License, as indicated by a copyright notice that is included in or attached to the Work as identified in Appendix C.

## 2. Grant of Copyright License.

Subject to the terms and conditions of this License, UW and each Contributor hereby grants Licensee a perpetual, worldwide, non-exclusive, no-charge, royalty-free, copyright license to reproduce, publicly display, publicly perform, prepare Modifications, and distribute the Work with or without Modifications, subject to the Limited Use of Identifiers in Section Four (4) of this License.

UW reserves the right to use information and Contributions provided by the Licensee in making changes to the FMA™. Licensee agrees not to allege or enjoin infringement by UW for any Modifications, extensions or other improvements prepared by UW, or by any third party obtaining Modifications, extensions, or other improvements under license from UW.

#### 3. Grant of Patent License.

Subject to the terms and conditions of this License, each Contributor hereby grants to Licensee a perpetual, worldwide, non-exclusive, no-charge, royalty-free, irrevocable (except as stated in this section) patent license to make, have made, use, offer to sell, sell, import, and otherwise transfer the Work, where such license applies only to those patent claims licensable by such Contributor that are necessarily infringed by their Contribution(s) alone or by combination of their Contribution(s) with the Work to which such Contribution(s) was submitted. #### 6. Submission of Contributions.

FMA™ is a unique ontology Work. The FMA™ Master Ontology is maintained by the FMA™ Research Project using UW computers and the application programs of the Structural Informatics Group, UW's Department of Biological Structure.

The sole responsibility and authorship of the FMA™ is the exclusive right of the UW and the FMA™ Research Project.

All Contributors wishing to recommend Modifications to the Release Version of the FMA™ shall complete a Contribution Agreement (Appendix B).

Unless Licensee explicitly states otherwise, any Contribution intentionally submitted for inclusion in the Release Version of the FMA™ by Contributor or Licensee to the FMA™ Research Project shall be under the terms and conditions of this License, without any additional terms or conditions. Notwithstanding the above, nothing herein shall supersede or modify the terms of any separate license agreement Licensee may have executed with Licensor regarding such Contributions.

These submissions may be referenced or reviewed by the FMA<sup>™</sup> Research Project at the sole discretion of the FMA<sup>™</sup> Research Project.

This License does not grant permission to use the trade names, identifiers, trademarks, service marks, or product names of the FMA<sup>™</sup>, Foundational Model of Anatomy, or UW, or the Licensor, except as required for reasonable and customary use in describing the origin of the Work and reproducing the content of the NOTICE file. # Appendix A

## "Release Version of the FMA™"

#### **Release File Format**

The Release Version of the FMA<sup>™</sup> is a snapshot of the FMA<sup>™</sup> and is current as of the date it is downloaded from the FMA<sup>™</sup> Research Project Website. The Release Version of the FMA<sup>™</sup> is currently available in a form suitable for import into a MySQL database with a specific relational database schema in a standard Protégé database schema.

#### **File Format Conversion**

The FMA™ is file format independent. File format conversions, such as conversions of the FMA™ as a whole to an alternative representation (such as OWL or OBO) from its Release File Format, are not considered original works of authorship. Such conversions will likely include modifications, insertions, and/or deletions of FMA™ content as necessitated by the representational constructs provided by the target language. File format conversions may also be characterized by modifications intended to enhance the utility of the ontology, in the target language, that are not significant anatomical content modifications (i.e. introducing closure axioms when converting to an open-world model such as OWL).

Any distribution by the Licensee of File Format Conversion shall include "FMA™" and the goodwill associated with the FMA™ mark. The licensor shall inspect all goods using the mark for quality. As a condition of the quality control inspection, Licensee shall provide all relevant material related to File Format Conversions to FMA™ Research Project prior to distribution.

In naming the File Format Conversions, the title shall use FMA<sup>™</sup> as the first element of the title. Examples of titles would be: "FMA<sup>™</sup>-OBO" or "FMA<sup>™</sup>-OWL."
